**AN ORDINANCE ACCEPTING THE BIDS OF  
J.D. STRIPING & SERVICES, INC., SPECIALIZED  
CONSTRUCTION, INC., SET IN STONE CONTRACTING, LLC,  
CUYAHOGA FENCE LLC, ASPHALT FABRICS & SPECIALTIES, INC.,  
CHAGRIN VALLEY PAVING AND LIBERTA CONSTRUCTION  
FOR VARIOUS PORTIONS OF THE 2019 ROAD MAINTENANCE  
PROGRAM FOR THE SERVICE DEPARTMENT OF THE  
CITY OF BRECKSVILLE; AND DECLARING AN EMERGENCY**

**WHEREAS**, pursuant to the publication of bids, according to law, bids for various portions of the 2018 Road Maintenance Program for the Service Department of the City of Brecksville in accordance with the specifications on file in the office of the Director of Purchasing, were received and opened according to law at 10:00 o'clock A. M. on January 11, 2019, and it being determined that the bids of J.D. Striping & Services, Inc., Specialized Construction, Inc., Set in Stone Contracting LLC, Cuyahoga Fence LLC, Asphalt Fabrics & Specialties, Inc., Chagrin Valley Paving and Liberta Construction were the lowest and best bids.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

**SECTION 1.** The bids of J.D. Striping & Services, Inc., dated January 11, 2019, for the Paint Striping of various City streets in an amount not to exceed \$47,686.00, and for Auxiliary Markings in an amount not to exceed \$30,289.00 all in accordance with the specifications on file in the office of the Director of Purchasing, be and the same are hereby accepted.

**SECTION 2.** The bids of Specialized Construction, Inc., dated January 11, 2019, for Pulvamixing, Asphalt Placement, Partial Planing, Pavement Planing (Unscheduled), Single Pass Pavement Treatment, Partial Depth Joint Repair for Concrete & Asphalt, Asphalt Pavement Pre-Seal Layer and for certain Equipment Rental in the various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same are hereby accepted.

**SECTION 3.** The bids of Set In Stone Contracting, LLC. dated January 11, 2019, for various types of scheduled Concrete Repairs, in various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

**SECTION 4.** The bids of Liberta Construction, dated January 11, 2019, for various types of Unscheduled Concrete Repairs, in various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

**SECTION 5.** The bids of Cuyahoga Fence LLC, dated January 11, 2019, for Guardrail Reconstruction & Replacement in the various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

**SECTION 6.** The bids of Asphalt Fabrics & Specialties, dated January 11, 2019, for Equipment Rental-Tack Coat Distributor in the amount of \$100 per hour, and SS1 Tack Coat Material in the amount of \$2.10 per gallon, and Tandem Axle and Tri-Axle Rentals in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

**SECTION 7.** The bids of Chagrin Valley Paving, dated January 11, 2019, for Pavement Planing (Scheduled Work) in the various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

**SECTION 8.** The Mayor be and hereby is authorized and directed to enter into contracts on behalf of the City of Brecksville with the said J.D. Striping & Services, Inc., Specialized Construction, Inc., Set In Stone Contracting, LLC, Cuyahoga Fence LLC, Asphalt Fabrics & Specialties, Inc., Chagrin Valley Paving and Liberta Construction as set forth in Sections 1 through 7 hereof, said contracts to be in such form as is approved by the Director of Law.

**SECTION 9.** The Council hereby appropriates sufficient funds to effectuate the provisions contained in Sections 1 through 7 hereof, and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Sections 1 through 7 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes as expressed in Sections 1 through 7 hereof, said amounts to be charged to the appropriately designated Fund.


**SECTION 10.** The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is that the same relates to the need for a road program, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
