Ordinance No. 5242

**AN ORDINANCE ACCEPTING THE BID
OF KOKOSING MATERIALS, INC. FOR
THE FURNISHING OF VARIOUS TYPES
OF ASPHALT FOR ROAD REPAIRS IN
THE CITY OF BRECKSVILLE;
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to the publication of bids according to law, bids for the furnishing of various types of asphalt for road repairs in accordance with the specifications on file in the office of the Director of Purchasing, were received and opened according to law on March 29, 2019, and it being determined that the bid of Kokosing Materials, Inc. was the lowest responsive and responsible bid.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. Per the bids received and as tabulated by the Director of Purchasing, the bid of Kokosing Materials, Inc. dated March 29, 2019, for the furnishing of Type 448-1 asphaltic surface course in the amount of \$75.00 per ton, Type 448-2 asphaltic surface course in the amount of \$70.00 per ton, Type 301 asphaltic surface course in the amount of \$69.00 per ton, recycled asphalt in the amount of \$63.50 per ton for surface course grade, \$54.50 per ton for intermediate course grade and \$54.00 per ton for Type 301, plus applicable delivery charges at \$9.75 per ton, or \$105 per hour for 24-ton truck and \$95 per hour for a 20-ton truck, in an aggregate amount not to exceed 18,000 tons during the length of the contract, for street repair requirements of the City, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

SECTION 2. The Mayor be and is hereby authorized and directed to enter into a contract on behalf of the City of Brecksville with Kokosing Materials, Inc. as set forth in Section 1 hereof, said contract to be in such form as is approved by the Director of Law.

SECTION 3. The Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.


SECTION 4. The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to make road repairs, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.


