12. **Ordinance No. 5040 (Third Reading)** - amending the Zone Map of the City of Brecksville by changing the classification of Royalton Road (SR-82) properties known as Permanent Parcel Nos. 603-03-014, 603-03-015, 603-03-016, 603-03-017, 603-03-019, 603-03-020, 603-03-021, from R-20 Residential District to O-B Office Building District, and to overlay on said parcels the O-L Office Laboratory District and M-D Manufacturing Distribution District, and to allow on said parcels the uses permitted in all said overlay zoning districts as conditional uses.
 - Motion to amend Ordinance No. 5040 to eliminate Manufacturing Distribution District as an overlay on said parcels and the uses permitted in said overlay zoning district as conditional uses.
 - Third reading of amended Ordinance No. 5040 amending the Zone Map of the City of Brecksville by changing the classification of Permanent Parcel Nos. 603-03-014, 603-03-015, 603-03-016, 603-03-017, 603-03-019, 603-03-020, 603-03-021, from R-20 Residential District to O-B Office Building District, and to overlay on said parcels the O-L Office Laboratory District and to allow on said parcels the uses permitted in said overlay zoning district as a conditional use.
