**A RESOLUTION AUTHORIZING THE PURCHASE OF AN  
ADVENGER X2805R-C OBC RIDER FLOOR SCRUBBER  
FROM THE HOME DEPOT PRO THROUGH OMNIA  
PARTNERS PURCHASING ORGANIZATION;  
AND DECLARING AN EMERGENCY**

**WHEREAS**, pursuant to the provisions contained in Section 9.48 of the Ohio Revised Code, the City of Brecksville deems it cost effective to purchase certain services and equipment through the Home Depot Pro through OMNIA Partners purchasing program.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

**SECTION 1.** The Mayor be and is hereby authorized to enter into a contract on behalf of the City of Brecksville with the Home Depot Pro through OMNIA Partners purchasing program, said contract to be in such form as is approved by the Director of Law, through its authorized vendor, Home Depot, for the purchase of the following:

The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes

**SECTION 3.** The Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to take advantage of the competitive costs obtained by OMNIA Partners, therefore, said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.
