**AN ORDINANCE TO AMEND ORDINANCE NO. 5457,  
MAKING APPROPRIATIONS FOR CURRENT  
EXPENSES OF THE CITY OF BRECKSVILLE  
DURING THE FISCAL YEAR ENDING  
DECEMBER 31, 2022, MAKING NECESSARY  
APPROPRIATION AND REVENUE ADJUSTMENTS;  
AND DECLARING AN EMERGENCY**

WHEREAS, the appropriations heretofore set to certain accounts of the City of Brecksville are insufficient to pay expenses incurred during the fiscal year ending December 31, 2022.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

**SECTION 1.** That the Director of Finance be authorized to increase appropriations in the Motor Vehicle Permissive License Tax Fund:


**SECTION 10.** That the Director of Finance be authorized to decrease appropriations in the Recreation Facilities Expansion Fund:
