**COUNCIL OF THE CITY OF BRECKSVILLE**

Ordinance No. 5566

**AN ORDINANCE ESTABLISHING THE  
COMPENSATION OF THE MAYOR FOR  
THE YEARS 2024, 2025, 2026 AND 2027;  
AND DECLARING AN EMERGENCY**

**WHEREAS**, pursuant to the provisions contained in Article IV, Section 6 of the Charter of the City of Brecksville, the compensation of the Mayor shall be fixed not less than one hundred and twenty (120) days immediately preceding the date of the next municipal election; which election will be held November 7, 2023.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

**SECTION 1.** Effective with the term beginning January 2, 2024, the compensation of the Mayor shall be fixed at the rate of one hundred twenty thousand, five hundred dollars (\$120,500) per year for the year 2024.

**SECTION 2.** Effective with the term beginning January 2, 2025, the compensation of the Mayor shall be fixed at the rate of one hundred twenty-two thousand, nine hundred ten dollars (\$122,910) per year for the year 2025.


**SECTION 3.** Effective with the term beginning January 2, 2026, the compensation of the Mayor shall be fixed at the rate of one hundred twenty-five thousand, three hundred sixty-eight dollars (\$125,368) per year for the year 2026.

**SECTION 4.** Effective with the term beginning January 2, 2027, the compensation of the Mayor shall be fixed at the rate of one hundred twenty-seven thousand, eight hundred seventy-five dollars (\$127,875) per year for the year 2027.

**SECTION 5.** Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is that the same relates to the need to meet the provisions of Article IV, Section 6 of the Charter; therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
