Ordinance No. 5602

**AN ORDINANCE ACCEPTING THE BID OF
ANTHONY ALLEGA CEMENT CONTRACTOR
FOR THE MILLER ROAD PAVEMENT
IMPROVEMENT PROJECT;
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to the publication of bids according to law, bids for the Miller Road Pavement Improvement Project, in accordance with the specifications on file in the office of the Director of Purchasing, were received and opened according to law at 10:00 a.m. on, March 24, 2023, and it being determined that the bid of Anthony Allega Cement Contractor was the lowest and best bid.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The bid of Anthony Allega Cement Contractor for the Miller Road Pavement Improvement Project in an amount not to exceed two million, one hundred thirty-four thousand, five hundred fifty-one dollars and fifty cents (\$2,134,551.50), in accordance with the specifications on file in the office of the Director of Purchasing, be, and the same hereby is, accepted.


SECTION 2. The Mayor be and is hereby authorized and directed to enter into a contract on behalf of the City of Brecksville with Anthony Allega Cement Contractor as set forth in Section 1 hereof, said contract to be in such form as is approved by the Director of Law.

SECTION 3. The Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.



The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to commence with the project, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.
