**AN ORDINANCE ACCEPTING THE BIDS OF
J.D. STRIPING & SERVICES, INC., SPECIALIZED
CONSTRUCTION, INC., SET IN STONE CONTRACTING LLC,
INDEPENDENCE CEMENT LLC, ASPHALT FABRICS,
COLE BURTON CONTRACTORS LLC, GEAUGA HIGHWAY CO.,
AND CUYAHOGA FENCE LLC FOR VARIOUS PORTIONS OF THE
2023 ROAD MAINTENANCE PROGRAM FOR THE
SERVICE DEPARTMENT OF THE CITY OF BRECKSVILLE;
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to the publication of bids, according to law, bids for various portions of the 2023 Road Maintenance Program for the Service Department of the City of Brecksville in accordance with the specifications on file in the office of the Director of Purchasing, were received and opened according to law at 9:00 o'clock A. M. on January 25, 2023, and it being determined that the bids of J.D. Striping & Services, Inc., Specialized Construction, Inc., Set In Stone Contracting LLC, Independence Cement LLC, Geauga Highway Company, Asphalt Fabrics, Cuyahoga Fence LLC and Cole Burton Contractors LLC are the lowest and best bids.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The bids of J.D. Striping & Services, Inc., dated January 25, 2023, for the Paint Striping of various City streets in an amount not to exceed \$63,424.20, and for Auxiliary Markings in an amount not to exceed \$41,859.90 all in accordance with the specifications on file in the office of the Director of Purchasing, be and the same are hereby accepted.

SECTION 2. The bids of Specialized Construction, Inc., dated January 25, 2023, for, Pavement Planing-Unscheduled Work, Single Pass Pavement Treatment, Pulvamixing, Partial Depth Joint Repair- Concrete (if needed) and for certain Equipment Rental in the various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same are hereby accepted.

SECTION 3. The bids of Set In Stone Contracting LLC dated January 25, 2023, for various types of Concrete Repairs-Scheduled Work Program, in various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

SECTION 4. The bids of Independence Cement LLC dated January 25, 2023, for Unscheduled Concrete Repairs and Commercial Drive Apron, in various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

SECTION 5. The bids of Cuyahoga Fence LLC, dated January 25, 2023, for Guardrail Reconstruction & Replacement in the various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

SECTION 6. The bids of Asphalt Fabrics, dated January 25, 2023, for Equipment Rental-Tack Coat Distributor in the amount of \$115 per thirty minutes, SS1 Tack Coat Material in the amount of \$2.75 per gallon, as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

SECTION 7. The bids of Cole Burton Contractors LLC, dated January 25, 2023, for Pavement Planing – Scheduled Work Program in the various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same is hereby accepted.

SECTION 8. The bids of Geauga Highway Co., dated January 25, 2023, for Partial Depth Joint Repair – Asphalt (if needed), Asphalt Placement, Partial Planing, Asphalt Pavement Pre-Seal Layer and for Tandem Axle-Equipment Rental in the various amounts as listed in the bid specifications, in accordance with the specifications on file in the office of the Director of Purchasing, be and the same are hereby accepted.


SECTION 9. The Mayor be and hereby is authorized and directed to enter into contracts on behalf of the City of Brecksville with the said J.D. Striping & Services, Inc., Specialized Construction, Inc., Set In Stone Contracting LLC, Independence Cement LLC, Geauga Highway Co., Cole Burton Contractors LLC, Asphalt Fabrics and Cuyahoga Fence LLC, as set forth in Sections 1 through 8 hereof, said contracts to be in such form as is approved by the Director of Law.


SECTION 10. The Council hereby appropriates sufficient funds to effectuate the provisions contained in Sections 1 through 8 hereof, and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Sections 1 through 8 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes as expressed in Sections 1 through 8 hereof, said amounts to be charged to the appropriately designated Fund.

SECTION 11. The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is that the same relates to the need for a road program, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
