Ordinance No. 5617

AN ORDINANCE ACCEPTING THE PROPOSAL OF IPROJECT SOLUTIONS LLC FOR THE SOLE SOURCE PURCHASE OF IPLANTABLE DESKTOP COMMANDER TOUCHSCREEN WORKSTATIONS FOR THE BUILDING DEPARTMENT; AND DECLARING AN EMERGENCY

WHEREAS, iProjectSolutions is the only authorized sales, service and support provider for the iPlanTable workstations; and

WHEREAS, the iPlanTable is a sole source product, manufactured, sold and distributed exclusively by iProjectSolutions, and no other company makes a similar or competing product that would serve the same purpose or function.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The proposal of iProjectSolutions for two (2) iPlanTable Desktop Commander Touchscreen Workstations for the Building Department, at a cost of fifteen thousand, one hundred seventy-five dollars (\$15,175.00), as outlined in Exhibit "A" attached hereto, is hereby accepted.


SECTION 2. The Mayor be and is hereby authorized and directed to enter into contracts on behalf of the City of Brecksville with iProjectSolutions as set forth in Section 1 hereof, said contracts to be in such form as is approved by the Director of Law.

SECTION 3. The Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof, and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes as expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.

SECTION 4. The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the Building Department's unique need for the workstations, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
