### A RESOLUTION COMMENDING GERALD F. BROSKI UPON HIS RETIREMENT FROM SERVICE TO THE CITY OF BRECKSVILLE

**WHEREAS**, Mayor Jerry N. Hruby and the Members of Council wish to sincerely commend the service Gerald F. Broski has provided to the City of Brecksville as a member of Council; and

**WHEREAS**, Gerald F. Broski started his term as a member of City Council on January 2, 1986, being the President of Council during 1987 and served as Vice President of Council from 2006-2008 and 2019-2020; and

**WHEREAS**, Councilmember Broski served as Chairman of the Streets and Sidewalks Committee from January 2, 1996 through January 2, 2019, Chairman of the Utilities Committee in January 2, 1990 through January 1, 1994 and as the Chairman of the Legislation Committee January 2, 1986 through January 1, 1990; and

**WHEREAS**, as during his tenure as a Councilmember, was also a member of the Buildings & Grounds Committee, Finance Committee, Legislation Committee, Safety Service Committee, Streets & Sidewalks Committee and the Utilities Committee; and

**WHEREAS**, Gerald F. Broski was also the Council Representative for (2) years to the Planning Commission from 1986 to 1988, Council Representative for (12) years to the Cable Television Advisory Board, now known as the Telecommunications Board, in 1988 to 1994 and 2012-2020, and Council Representative for (4) years to the Volunteer Firefighter's Dependents Board; and

**WHEREAS**, Gerald F. Broski was also appointed the Income Tax Review Board and served for (22) years from 1988 to 1994 and from 1996 to 2014; and,

**WHEREAS**, throughout his years of service, Councilmember Broski demonstrated civic leadership and has given unselfishly of his time, wisdom and knowledge; and

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio that:

**SECTION 1.** The Mayor and Council extend their most sincere heartfelt best wishes to Gerald F. Broski upon the momentous occasion of his retirement from the City of Brecksville.

**SECTION 2.** The Mayor and City Council wish to publicly commend and express their undying appreciation to Gerald F. Broski for his years of dedicated, loyal, and compassionate service to the City of Brecksville and urge all residents to reflect upon and acknowledge Gerald F. 
